Lead poisoning poses a particular risk to pregnant women. The seller of any interest in residential real property is required to provide buyer with any information on lead-based paint hazards from risk assessments or inspections in the seller's posses and notify the buyer of any known lead-based paint hazards. A risk assessment or inspection for possible lead-based paint hazards is recommended prior to purchase.
