No detached storage buildings or any other structures, including, but not limited to storage barns, sheds, or outbuildings of any kind, above ground or on-ground swimming pools, temporary or otherwise, may by built on any lot except facilities servicing an inground swimming pool, and these must meet the approval of the majority of the property owners or their designated representative. It is the intention of this covenant to only allow in-ground swimming pools which pools are completely flush with the ground. For purposes of these Covenants, Structure is defined as anything constructed or erected which requires location on the ground or attachment to something having a location on the ground.

B. Paragraph 18. Severability; shall be amended to read as follows:

PARAGRAPH 18. SEVERABILITY:

Invalidation of any one of the covenants or restrictions contained in this Amendment or the Restrictive Covenants shall in no way affect any of the other provisions, which shall remain in full force and effect. Any lot owner shall have the right to enforce, by any proceeding at law or in equity all restrictions, conditions, covenants, and or easments now or hereafter imposed.
